Also, if NRS refers this account for collection or files a lawsuit for collection, BUYER agrees to pay reasonable attorney fees and costs.

BUYER acknowledges that all financial and credit functions are processed through NRS's corporate offices in Moscow, Latah County, Idaho. BUYER therefore agrees that in any court action brought in connection with BUYER's account with NRS, any such court action must be brought in Moscow, Latah County, Idaho. BUYER agrees to be bound by the jurisdiction of the courts of Moscow, Latah County, Idaho, and that Idaho law shall apply to all transactions and any court actions between NRS and BUYER. BUYER gives permission to NRS, its agents, representatives, and assigns, to verify and/or supplement open account credit information, and agrees to execute any and all documents requested by NRS to verify BUYER's status.
